#### Road Issues in The Glens

Merivale Road Speed Camera—Residents can look forward to traffic moving at a reduced speed along Merivale Road beginning this Fall with the deployment of an automated speed camera in front of St. Monica's School. MacFarlane Road Traffic Calming—After being approved in 2022, residents can look forward to construction starting this summer to implement traffic calming measures along MacFarlane Road. The measures will include speed cushions (similar to speed bumps, but not covering the entire width of the road), raised bus platforms, as well as improvements to the intersections at Deakin and Merivale.

Grenfell Cres. Near Woodroffe— Work is scheduled for the resurfacing of Grenfell within 300m of Woodroffe to address the portion that leads onto Woodroffe where the road's deterioration is notably worse. Within the scope of the resurfacing project, the City of Ottawa will be installing subdrain, an engineering solution to drain water from the base of the road. A commitment was made by both Public Works and the NCC to work towards alleviating area drainage issues through ditching and improvements to the overland drainage system. With these improvements, a reduction in the water level is expected to address the heaving of the pavement.

# Changes to Garbage Collection Coming in the Fall



In June 2023, Council voted to limit households to 3 bags of garbage every 2-weeks in order to reduce the amount of waste being deposited at the Trail Road Landfill. The new limit comes into effect on Monday, September 30, with a phased-approach to the cap. In October, if more than 3 bags are left for collection, everything left at the curb will be collect-

ed, but crews will leave behind a non-compliance tag indicating how to participate in waste diversion programs. In November, crews will remove all but one bag, leaving one bag and a non-compliance tag. Finally, in December, crews will remove only three bags, leaving behind any excess along with the non-compliance tag.

A garbage item can be a garbage bag, a 140-litre container or bulky item that is set-out within the size and weight parameters. Households can place multiple smaller bags in the 140-litre container. The <a href="Special Consideration waste program">Special Consideration waste program</a> (www.ottawa.ca/en/garbace-and-recycling) for residents requiring collection of diapers and incontinence products will continue and will be expanded to include non-hazardous medical waste.

#### **GCA Member Data Cleanup**

Work continues on the cleanup of GCA membership data. Over the coming months, you may receive an email requesting that you provide or update the information that the GCA has on file for you. This helps to ensure that our records are up to date, and that any out-of-date information is purged from our files.

#### **Storm Water Rate Changes**

The City has embarked upon a review of how costs to deliver water services across the city are recovered. For most households in the Glens, stormwater billing is the only component of the review impacting costs to residents. For privately serviced properties, stormwater charges are shown as a separate line item on property tax bills and are based upon the assessed value of the property. Following a report to Council in 2016, charges approved phased in over a 4 year period beginning in 2019. Prior to implementation, the Glens were not subject to charges for stormwater. As part of a relatively small number of privately serviced areas within the urban boundary, the Association feels it important that our unique circumstances within the urban boundry are considered as part of the rate review. One of the options that staff have been exploring is the idea of using the amount of impervious surfaces on a property as the basis for charges. Impervious surfaces are areas on a property that are considered highly resistant to water absorption, such as pavement, asphalt, concrete, brick, building material and/or structure rooftops. Questions remain regarding how this information can be accurately collected. We intend to have a representative of the City available at our AGM to discuss the rate review and allow residents to provide feedback to the City.

#### **Eastway Tank Conviction and Memorial**

On April 5th, Eastway Tank and Meter Ltd., and its' owner Neil Greene pleaded guilty to charges under the Ontario Occupational Health and Safety Act (OHSA). The following allegations were made against both Greene and Eastway:

- 1. That Eastway Tank and Greene failed to ensure that the process of loading and "wet testing" a truck, "that produced a vapour to such an extent as to be capable of forming an explosive mixture with air, was carried out in an area with no potential sources of ignition."
- 2. That Eastway Tank and Greene failed to take on one or more or the following reasonable precautions in the workplace:
- Ensure that diesel fuel to be used for the wet testing of trucks was not contaminated with gasoline or any other flammable liquid of substance.
- Ensure that the tank of the truck did not contain and was free of gasoline or any other flammable liquid or substance, while work and/or testing capable of being a source of ignition was taking place on or near the truck.
- Ensure that the truck and fuel hose nozzle(s) were bonded and grounded while the truck was loaded and/or wet tested with fuel. Ensure that fuel was not splash loaded or splash filled into the tank of the truck.
- Ensure that flammable liquid vapours in the tank of the truck were not exposed to a source of potential ignition.
- 3. That Eastway Tank and Greene failed to provide adequate information, instruction, and supervision to workers on safe fuel storage and handling procedures to protect the workers from the hazard of diesel fuel, used for the wet testing of trucks, becoming contaminated with gasoline or any other flammable liquid or substance.

Eastway was ordered to pay a total fine of \$600,000 plus a 25% victim surcharge and Greene was ordered to pay a fine of \$80,000 plus a 25% victim surcharge. The fine levied upon Eastway is the largest ever against a company of Eastway's size in the history of OSHA and the fine against Greene is amongst the largest ever against an individual. Justice Mitch Hoffman said that he took into consideration the remorse shown by Greene and the company through the plea of guilty'. Eastway faced a maximum fine of \$1.5 million and Greene faced a maximum of 12 months in jail along with a fine of up to \$100,000.

A permanent memorial dedicated to the victims of the explosion was unveiled in Merivale Gardens Park, consisting of a new bench, in front of a memorial plague, and a tree for each one of the six victims killed in the explosion.





Through the Fall of 2023, residents had the opportunity to vote for their preferred design for the new play structure for Pineglen Park. The results showed a clear preference for the second option, which was chosen by 60% of respondants. Although the original concept drawings did not include an overhead trolley element, due to resident comments, this feature was added to the final design. The most recent update from the City is that the project is currently out for tender, with a closing date in May. Once the contract is awarded, we can look forward to an updated schedule for construction and completion.

#### Roses Are Red, Violets Are Blue: Gardening Tips



If you're passionate about gardening, consider these helpful suggestions for the upcoming season: **Help Pollinators**:

Delay Spring Cleaning: Many pollinators and wildlife overwinter in dead plant stems or leaf litter. Wait until temperatures consistently rise above 10°C before tidying up.

- Native Wildflowers: Plant native wildflowers, including early and late flowering species, to provide nectar sources for pollinators.
- Bee Hotels: Consider installing a bee hotel to support native solitary bees. These smaller structures provide nesting spots for these essential pollinators.
- Reduce Lawn Area: Convert parts of your lawn to native wildflower gardens or meadows to benefit pollinators year-round.

#### Soak Up the Rain:

- Rain Gardens: Create shallow, depressed areas planted with attractive hardy plants (preferably native perennials). These gardens promote rainwater infiltration into the ground.
- Choose Wet-Tolerant Plants: Opt for hardy plants that can handle both wet conditions and occasional drought.


